



# Subscriptions Policy

Updated 13/01/2026

## 1. Purpose

The purpose of this policy is to set out the Club's Subscription's Policy.

## 2. Scope of Policy

This Policy applies to management committee, staff and members.

## 3. Policy

**3.1** The Nenagh Golf Club members subscription will be determined each year at the Club AGM.

**3.2** The Subscription payments will be overseen by the Club Subscription secretary, assisted by the office administrator.

**3.3** The invoices for the different categories of invoices will be sent out to members by the first week in January unless in unusual circumstances at another date agreed by the Management Committee.

**3.4** The categories agreed at the 2023 AGM are as follows:

Ordinary, Family, Country, Student, Junior cadet, Clubhouse, Honorary

The Management Committee recommended the following Category rates for membership applicable from January 1<sup>st</sup> 2024.

- Ordinary Members €800.00
- New Ordinary Members €800.00 Less 25% first year or part thereof and the following year. Membership must be lapsed for a period in excess of 5 years.
- Family €1350.00
- Spouse of Life Member- Difference between family and Ordinary Subscription.
- Student Members 10-17 years of age €200.00
- Student Members 10-17 year of age in the same family €150
- Students 18-24 years of age €250.00
- Country Members €500.00
- Clubhouse Members €100.00
- Cadet Members (under 10 years of age) € 50.00

**3.5** A Social contribution of €40 is applicable to life and ordinary members/family €80.00 (€40 x 2)

**3.6** Cash is NOT acceptable as payment for membership fee.

**3.7** All membership fees must be paid on or before February 28th each year, unless the member has entered into a direct debit agreement with the subscriptions Secretary. All members using this facility will be monitored each month to ensure payments are up to date. If a payment defaults, the individual is contacted immediately and all payments must be updated within two weeks of contact. If Payment is not updated see section 3.8



# Subscriptions Policy

**3.8** Where a members subscription remains unpaid at the 31<sup>st</sup> March membership (or whose Direct Debit has defaulted) shall be deemed to have lapsed and the name of such a member shall be removed from the Register of Members/ Club VI system/ Golf Ireland, except in exceptional circumstances where the Committee of Management, at its absolute discretion, decides to extend the period of payment. The Subscriptions Secretary shall inform the Men's and Women's Secretaries of the name of any such member and the committee concerned shall not allow that member to compete in any club or Open competitions under its control.

**3.9** In the event of an application for membership being rejected, the applicant will immediately be contacted. No further membership application from that applicant will be accepted until the following season.

**3.10** A member may request a credit arrangement or membership reduction due to illness. A medical certificate must be provided to the Management Committee on application request. Partial ability to play is not considered as grounds for reduction of membership fees. It is the sole decision of the Management Committee if a reduction is warranted.

**3.11** Approval of an application by the Management Committee does not result in immediate admission as a member. Admission will be confirmed once capacity becomes available in the relevant category.
